### Wollongong – Aboriginal background

The Wodi Wodi are the Aboriginal custodians of the Illawarra who spoke a variant of the Dharawal language. Dharawal speakers lived and live in the country from Botany Bay and Campbelltown in the north through the Nepean, Wollondilly, Georges, and Cataract water catchments, west to Moss Vale (Illillawatta) and south to the Shoalhaven River and Jervis Bay.




Figure 1: Dharawal and their neigbours

### **Wollongong – European background**

- <u>8 April 1770</u> Captain James Cook's Endeavour noted the Illawarra shores 'Red Point' (Port Kembla)
   <u>26 March 1796</u> George Bass and Matthew Flinders come to the Illawarra in their boat the Tom
   Thumb near Red Point.
- early 1800's Unofficial visits to Wollongong area.
- <u>About 1807</u> Bushman Joe Wild assisted bird collectors to enter the area.
- <u>1812</u> First load of cedar shipped from Illawarra.
- <u>1815</u> Dr Charles Throsby entered the area guided by Aboriginals using Aboriginal trail down Bulli mountain.
- <u>1 November 1816</u> Macquarie those who were promised land grants to meet at Throsby's stockman's hut, followed by Surveyor-General John Oxley and surveyor James Meehan measuring land grants near Lake Illawarra.
- <u>1819</u> Charles Throsby Smith arrived in the colony at the request of his uncle, Dr Charles Throsby.
- <u>1822</u> Charles Throsby Smith obtained a grant of 300 acres in Illawarra. Much of Wollongong is built on that grant.
- <u>2 May 1833</u> Surveyor Elliott draws plan of the Private Town of Wollongong .
- <u>1841</u> Census showed there were 637 males and 294 females in Wollongong.


Sketch of the Reserve at WOLLONGONG themen the angles of unes and the Contents

Appointed Deputy Postmaster in Wollongong October 1835, and Clerk of the Court shortly after this date.



Appointed 14 May 1838 after dismissal of James O'Brien Croker for forgery. Died 13 June 1839, aged 52








## New Court-House, Wollongong February 1857 design – plan enlarged



We hope that some steps will be taken to prevent the perpetuation of so great a blunder."



"OUR NEW COURTHOUSE.—A few weeks ago we made some strictures on the plan of a new Courthouse for this town. .... we are happy to say this it is not only much improved in its internal accommodations, but greatly superior in external appearance, in fact it will be quite an ornament to the town.... There is one improvement, however, .... to erect the building at the corner of the paddock, .... so that the front should face the harbor.... produce a favourable impression upon the minds of visitors arriving by steamers."



"The Bench of Magistrates sat in the new Court-House, Wollongong, for the despatch of business on Monday last. No ceremony marked the occasion from the ordinary sittings.... Altogether, we think we are correct in saying that this structure will be found equal to the wants of the district for some time to come.... the greatest care has been bestowed on the erection of the building by and under the direction of Mr Stoddart, the contractor, Mr Dawson, the Colonial Architect, has frequently inspected the work during its progress with the utmost attention, with the desire to make the building creditable in appearance as well as adapted to the purpose for which it was intended."





### **New Court House – First additions**

- The lack of weatherproof witness accommodation was raised soon after the opening by the Magistrates.
- This issue was raised in the Illawarra Mercury articles of the 2<sup>nd</sup> and 23<sup>rd</sup> March 1857 but not commented on in the article on "The Opening of the New Court House".
- It was added in 1866.

The verandah shown at the rear did not appear on the outline plan of 1864. It does appear on an 1890 plan.
In the absence of documentary proof, it is assumed that it was added in the late 1880's

### New Court House – Clerks of the Court

### Alfred Allaston Turner:

- Worked as Clerk of the Court and Clerk of Petty Sessions in the new Court House from its opening on 1 February 1858 to 20 May 1869.
- Sworn in as magistrate on 21 May 1869 before Mr Justice Hargrave.
- Died of Cancer on 3 August 1895, aged 68

### Mr. (James) Frazer:

- No record found of his appointment (assumed to be upon the appointment of A.A. Turner as magistrate
- Recorded in the Illawarra Mercury of 30 November 1869 "Mr. Frazer acted as Clerk of the Court".
- References continue in Illawarra Mercury articles until the closure of the "New Court House" in 1885.


### New Court House - 1858 to 1885

- It also dealt with insolvencies, registrations and licensing.
- Various official functions and community events requiring a hall

At the Wollongong Police Court on Monday, 16th instant, before Messrs Smith and Turner. Patrick McDonnell and Sydney Albert Downie, two young men of between 20 and 25 years of age, appeared in custody to answer a charge of having unlawfully assaulted one Phillip McMahon while driving her Majesty's mail between Campbelltown and Wollongong..... Downie said "Don't let him drive or I will give you an ounce of lead in your -----;" ..... Other charges were heard against the prisoners on Tuesday, and both were committed for trial at the Quarter Sessions"

#### LOCAL NEWS.

**Court of Petty Sessions.** 

Monday, 22nd May,

(Before the Mayor and C. T. Smith, Esq., J.P.)

Percy Owen, Esq, was charged with allowing two Horses, his property to stray in the public street in Wollongong.

For the defence Mr. R. Owen called James Kiernan, who deposed that he takes in horses and cattle to graze, and had the horses mentioned in his charge; they got out on the 16th instant, through Mr. Biggar knocking the fence down.

There being no negligence on the part of the defendant proved, and other animals shown to have strayed out at the same time, the complaint was dismissed.

(Mr. Waring took his sent on the Bench)

Benjamin Fawcett was charged with a similar offence. The defence set up was, that the slip-rails of the paddock in which tho horses were, must have been pulled down by some person.

A witness, William Chapman, swore that they could not have fallen down; he put them up securely.

Complaint dismissed.

### **Court House – Judicial use**

Thursday, May 6, 1858



John Crisp v. Thomas and Maria Dawson, for £10 for damages sustained by slander. It appeared from the evidence of plaintiff and a Mrs Dunn, that tho defendant had said that Crisp's wife should say as how Crisp had stolen some property belonging to Mrs Dunn. Crisp had quarrelled with his wife, and she, tho defendant, affirmed, had told her what she had told Crisp.

In answer to questions from the Bench, Crisp said he had hitherto bore a good character and he thought the charge of stealing would be likely to injure him. The Bench dismissed the ease.

"(From the Illawarra Mercury of Yesterday.) BLACK'S BLANKET DAY. - On Thursday, 1st April, we witnessed the distribution of blankets to the blacks at Wollongong..... Dr. Ellis – a most polite and loyal darkey – induced the rest to "bail up" together, and then called upon them for three cheers for the Queen, which was given with a hearty vociferousness which could only be excelled by their conquerors, and was followed by three more for the Magistrates, and another three for Wollongong. The blacks then dispersed."

The first meeting of electors to be held at the Court-house, Wollongong, on Tuesday, 22nd March."









### **Custom House - alterations**

#### Extract from 1890 Plan



- Compare the detail in the two extracted plans and specifically the right hand one.
- The area between the 'new Custom House' and the 'old weatherboard custom house' was covered in .
- From the dates of these plans, the alterations were made between 1890 and 1902 .
- From plans ,with known dates, at some time between 1885 and 1890 the stables were removed and replaced with the WC and Store shown in the left hand plan
- Little is known of the inside layout of the 'new Custom House', however a check of the left hand plan shows the door between the two small offices at the bottom was retained.


This doorway was bricked in at some time during the Drill Hall era.

### **Custom House – Weatherboard Building**



"The L.S.N. Company's arrangements at the wharf at Wollongong are a source of great inconvenience, and a just cause of complaint to passengers either shipping or landing at this port, ..... A considerable portion of the angle of space between the south side of the jetty and the stone wall of the pier at the rear of the store, and at <u>present partly occupied by the custom house</u> and the receptacles of pollution. By that means a spacious and commodious platform would be provided there for the convenience of passengers and the general public. A hand rail for public safety ......"

From the description, above, the "custom house" was situated adjacent to where passengers, arriving by steamer at Wollongong Harbour, disembarked.


The 'custom house', the weatherboard building now located behind the old court house, was also believed to have been located on Brighton Lawn. If the 'platform' was built ('for the convenience of passengers') this may well have been the reason it was moved there.

### **Custom House – Weatherboard Building**

- Despite having been moved several times and the chimney (it is assumed) rebuilt each time the building is essentially the Custom House that was located on Brighton Beach and adjacent to the passenger wharf of Wollongong Harbour.
- During its time adjacent to the 'new custom house' it was used as store.
- It was not until the Drill Hall era that it was made into an Officers' Mess and a small partition enclosing a kitchenette to the right of the entry door was added.

### **Custom House – Threat from Gaol**

#### Thursday, March 10, 1887



"There is a movement going on just now between the gaol authorities and the Customs Department, with a view of having a considerable portion of the site of the Wollongong Custom House (the old Court House) fenced off and added, as may be said, to the adjoining gaol entrance. The matter is one that should not receive sanction for a moment. .... Certainly a new roadway to and from the gaol should be made, but such should be in the most direct line ... It would be a pretty state of affairs to have the Custom House rights of the third most important sea-port of the colony over-ridden by a tenth-rate gaol."

Needless to say the plan did not eventuate, the direct route won the day.

It may be observed that the Illawarra Mercury has not lost its touch of 'fearless' reporting of a local cause.

# Custom House – Customs use

The Illawarra Mercury

Tuesday January 7, 1879

**Customs Duty**:— The fact that the first money for duty in connection with the port of Wollongong was paid during the past week is not unworthy of public notice. On a case of biscuits from Melbourne being landed from the Albert the Good for Mr. John Biggar, of this town, a few days ago it was found that a penny per pound duty had to be paid on them to the Customs officer of the port (Mr. F. R. Cole). The duty, amounting to a few shillings, was paid, constituting as it did the first such sum realized in connection with an Institution which is certain to extend in after years to immense proportions. And who can tell that in the far future some historian like Mr. Lindsay, whose record of shipping has made his name famous, may not then ransack the papers of the Wollongong Custom House, and relate to posterity the fact that we here announce to our readers.

Note this predates the move of Customs to the Old Court House in 1885, but is worthy of showing the function of Customs as well as recording the first customs duty paid on imported goods in Wollongong.

The following prizes were won by the Wollongong Company:- First in regimental shield, cross guns and swords (1<sup>st</sup> class company), gold cup and medals for fastest and best gun detachment in the regiment. Corporal E. Oberg secured the first prize for best gun-layer in the Australian Garrison Artillery."

### **Postscript**:

Lord Kitchener was apparently the guest of honour at the competition and presented the awards to No.4 Company, upsetting the 'more favoured' Company's from Sydney.



The discontent which has been prevalent amongst the ranks of the militia companies of late owing the Government failing to make provision for the upkeep of the regimental staff, has now reached Wollongong. For weeks past matters in connection with the local garrison artillery have not at all been too satisfactory, and quite a number of its members have expressed themselves very forcibly.

Matters reached a climax to-day, when the whole of the No.4 Company A.G.A., numbering over 60 members, resigned. They state their reason for doing so is owing to the fact that the regimental staff has been abolished.

The loss to the Commonwealth of a company such as the No.4, A.G.A., will be keenly felt, for they have proved themselves on quite a number of occasions to be the best shots in the Commonwealth with the big guns. Their shooting in the last two encampments at Middle Head proved them to be superior to any other company.

The corps appeals for voluntary helpers to assist on Dec 16, when the Sea Cadet Corps will be conducting State-wide sale of buttons. Any person who can spare a few hours on that day is asked to contact the Commanding Officer at the Drill Hall, Wollongong.



# Drill Hall – Army & Navy Historical Inconsistencies

- The armed services involvement in the Drill Hall, Wollongong from 1904 is clear from supporting documents
- The use of the Drill Hall by the following is established:
  - No.4 Garrison Artillery
  - 37<sup>th</sup> Infantry Regiment
  - 3<sup>rd</sup> Battalion
  - 34<sup>th</sup> Battalion
  - Naval Cadets

RESEARCH CONTINUES IF YOU CAN HELP IT WOULD BE APPRECIATED

- There appears, however, to be substantial overlaps between some of the groups as to when each used the Drill Hall.
- By way of example:
  - It is believed that the 3<sup>rd</sup> Battalion was involved in the 1938 extensions to the Drill Hall and handed over to the 34<sup>th</sup> Battalion in 1950 who in turn handed over to the Naval Cadets in 1974; YET
  - The 3<sup>rd</sup> Battalion was recruiting, with reference to the Drill Hall in the Illawarra Mercury in 1952, AND
  - Newspaper reports and other documents show that the 34<sup>th</sup> Battalion was using it in 1939, 1940 and as far back as 1934; AND
  - Newspaper report s show that the Naval Cadets were using it in the late 1940s
